Eastern Carolina Region Receives \$900,000 to Expand Employment and Training Opportunities to the Region's Exiting Military and Military Spouses

NCER's Military Growth Task Force Inc. recently announced that the N.C. Department of Commerce and the Division of Workforce Development (DWD) had awarded the Military Growth Task Force in partnership with the Eastern Carolina Workforce Development Board, Inc. a workforce development grant totaling \$900,000 from the American Recovery and Reinvestment Act funds received by the state of North Carolina. This grant award is part of Governor Perdue's JobsNOW initiative, and will be administered by the Eastern Carolina Workforce Development Board, Inc.

"The Veterans Initiative Project (VIP) is a result of strategic planning efforts through the Military Growth Task Force to attract and retain veterans and military spouses in Eastern North Carolina to fill many of the needed jobs requiring their unique attributes," said Jay Bender, Interim Executive Director for NCER's Military Growth Task Force.

The project will provide training and skill certification opportunities in high demand, high growth sectors through the region's community colleges to eligible



veterans and military spouses, which will result in employment. Proving to be a WIN-WIN partnership, this project is designed to address the employment needs of local businesses, as well as those of our military community.

Priority for training services will be made available to veterans who desire to remain in North Carolina and eligible military spouses entering the workforce or transitioning between jobs and careers, as well as those who are underemployed and in need of new skills to move up the career ladder.

Training needs and skill shortages have been identified in the high growth/demand areas of health care, education, child care, construction/skilled trades, emerging green jobs, aviation/aerospace, and advanced manufacturing.

VIP services will be delivered through the local JobLink Career Centers in partnership with Coastal Caro-

lina Community College in Jacksonville, and the local Employment Security Commission/JobLink offices located in New Bern and Goldsboro.

Through the Governor's "JobsNOW 12 in 6" initiative, local community colleges will offer short-term training programs in several of these high demand clusters to include: Nursing Assistant, Phlebotomy, Healthcare Billing/Coding, Office/Clerical Support, Masonry/Tile Cutting, Plumbing, Carpentry, Welding, Food Service, Auto Body Repair, Manufacturing, and HVAC/Industrial Maintenance. "We are excited about being able to offer these education and employment services to our military community", added Mona Padrick, Chair of the Eastern Carolina Workforce Development Board.

The 2009 Governor's Awards for Excellence in Workforce Development awards will be presented at a banquet on Thursday, October 8, from 6:30 p.m.-9:00 p.m., in conjunction with the NC Workforce Development Partnership Conference being held October 7-9 at the Sheraton/Koury Convention Center in Greensboro.

North Carolina's Eastern Region (NCER) Announces the Formation of a Defense/Aerospace Advisory Committee

North Carolina's Eastern Region (NCER) announces the formation of a Defense/Aerospace Advisory Committee. The committee is comprised of 17 members including NCER Board members, industry representatives, academia, government officials, and other business associates with relevant interests in the development of the defense/aerospace cluster in Eastern North Carolina.

The committee will serve as a think tank regarding needs, opportunities, strengths, and strategies for the development of this cluster in the region. It will address issues related to research, business creation, retention and attraction, as well as workforce development and education. It will also promote networks to encourage greater collaboration among industries, researchers, and universities to facilitate technology transfer and the commercialization process. Currently, the cluster consists of approximately a dozen or so companies employing more than 5,000

workers with expectations for growth of about 20% during the next five years. John Chaffee, President and CEO of NCER explained, "The committee will bring together the region's leaders to develop strategies that will most effectively strengthen our emerging defense/aerospace cluster. Ultimately, the region will benefit as a result of the committee's work from increased investment by new and expanding defense/aerospace businesses." Mr. Chaffee further explained that the committee will also be involved in promoting the region as an attractive location for the defense/aerospace industry.

While the region has benefitted from the presence of several significant defense and aerospace companies (Honeywell, Eaton, AAR for example), the creation of the committee is largely accredited to the decision by Spirit AeroSystems to locate at the Global TransPark (GTP) and the State of North Carolina's emphasis on this developing cluster. With the anticipated

June 2010 start-up of Spirit, the world's largest supplier of commercial airplane assemblies and components, the GTP has a major tenant that has enhanced NCER's ability to promote the cluster as a significant economic engine within the region. With the goal of promoting the region as a defense/aerospace (or aviation) cluster, the committee will build consensus and effectively target opportunities to leverage the region's current resources to compete in the global economy.

NCER is a 13-county partnership established by the General Assembly to promote economic development in Nash, Edgecombe, Wilson, Lenoir, Pitt, Wayne, Greene, Duplin, Pamlico, Jones, Onslow, Craven and Carteret Counties. The region encompasses almost 7,000 square miles and approximately one million residents. For more information contact Len Kulik, Vice-President, at kulik@nceast.org.

Craven County Economic Development Director Appointed to the North Carolina Economic Development Board



Jim Davis, Craven County's economic development director, was recently sworn in at his first meeting of the North Carolina Economic Development Board in Raleigh following his appointment by Gov. Bev Perdue.

One of only two county economic development directors on the 37-member board of state cabinet members, business leaders and key educators, Davis said his appointment is an honor and a challenge that he doesn't

take lightly.

Challenged with helping oversee state economic development research and planning and making policy recommendations to the commerce secretary, governor and General Assembly, the board helps develop strategy and recommend appropriations for state economic development programs. It also works with regional partnerships and state departments to help grow jobs in the state.

"It's not just about bringing jobs here, but knowing what the state can do for them. We have to keep ourselves aware of those industries in the eastern part of the state that will be a big component of the future." Davis said airplane components and composites used in manufac-

turing are some of those key elements.

Davis said Perdue's challenge last week to the North Carolina Economic Development Board was "to help lay the foundation for key and emerging industries so we'll be ready when the economy recovers."

Even in an economic downturn, North Carolina continues to recruit business and industry, Davis said, and the governor is looking for new strategies from her appointees along with renewed focus on those sectors of the state's economy that are holding their own.

North Carolina Breaks into Top 10 Nanotech States

Raleigh moves into the top five Nano Metros

A new study shows that North Carolina has broken into the top 10 states in the nation with the highest concentration of nanotechnology companies, universities, research laboratories and organizations, and that Raleigh has moved into the top 5 cities designated as "Nano Metro" clusters. The data was released by the Project on Emerging Technologies, which is a partnership between the Woodrow Wilson International Center for Schol-

ars and the Pew Charitable Trusts. This is the first time North Carolina has been a top-ranked nanotechnology region. "Nanotechnology is fundamental to North Carolina's economic development strategy of growing jobs and building a new economy," Perdue said. "As one of the top 10 nanotech states, North Carolina will continue to push ahead and lead a technology sector that will change every industry and create products that will change the way we

live." The data was released by the Project on Emerging Technologies and features more than 1,200 organizations across the United States that are part of the nanotechnology industry. North Carolina joins California, Massachusetts, New York and Texas as one of the top 10 states. Raleigh pushed out Oakland to become one of the top 5 Nano Metros. PCC Played Major Role In A Week That Changed A Life

Dislocated Hatteras Worker Receives Assistance Through WIA



In chronological order - he had his 51st birthday, got a raise at Hatteras Yachts, was part of the first lay-off at Hatteras, attended an opportunity expo for laid off workers, learned about the Workforce Investment Act (WIA) at Pamlico Community College, applied for assistance, and enrolled in his first class at PCC - all within the seven short days of one week.

Bryan Carawan, a native of Vandemere, when he was just a toddler, had water infused in his veins when his dad would jump off a dock holding Bryan on his shoulders. Though his family moved to Siler City, he never stopped calling Pamlico County home. A little sidebar to his Siler City days, one of his high school teachers rented a garage apartment from Aunt Bee of The Andy Griffin Show. He and friends visiting the instructor found her "very nice but a little eccentric." After high school, with water still circulating in his arteries, he joined the Navy to see the world. That he did. He was on the last

American vessel to pass through the Panama Canal before the Panamanians took over the Canal Zone. He found Singapore, with strict enforcement of environmental laws, to be one of the most beautiful places he visited. But the beauty of Singapore and Hawaii did not compare to his love for the beauty of Pamlico County. He moved back in 1984, first to work on commercial fishing vessels, following in the footsteps of his father, grandfather, and great grandfather.

After a few years, he and his wife, a Thomasville native, tried life in that city in the Western Piedmont. But by 2001, he was back in New Bern and ultimately a job at Hatteras Yachts installing electrical and electronic gear in 80 and 100 foot yachts. Acknowledging that Hatteras employees were aware that pink slips were coming, he said, "The day it happened, I went home. I'm a man of faith. I read some passages from the Bible and found inner peace. I didn't go around wringing my hands saying 'Woe is me.'"

Laid off on a Thursday, he attended the meeting on Monday where he learned about WIA programs to put people back to work. He then visited Pamlico Community College and talked with staff in Student Services who directed him to Cristy Lewis in the college's JobLink Career Center. He said, "It was unbelievable. When I walked into her office,

the people I had first talked to had alerted her that I was coming. It was as if she knew me and knew what I needed. From that point on, the college staff walked me through the process of qualifying for assistance."

On the evening of the very day that Carawan received approval for WIA assistance, he was in an electrical/electronics class. It was just a week after being handed the pink slip from Hatteras. Now Carawan expects to graduate in 2010. He is thinking about seeking civil service work at Cherry Point or trying to return to the work he loved, marine electrical installation and maintenance. He will be ready to re-enter the workforce with education and training to enhance job security. Dr. Clark Dimond, Dean of Institutional Advancement, and Dr. Larry Gracie, Chief Academic Officer, echoed similar sentiments. Gracie said, "This institution is all about finding answers for people who need more education and training." Dimond said, "We strive to provide customer service and that means finding the right pathways for students to succeed. That's what we have done for Bryan Carawan. And that's what we are here to do for all people we can help in this fragile economy."



Carteret County JobLink Partners Hold Annual Appreciation Luncheon

In the two years since Robin Critzer's husband died, she has gone from being an older adult without a job or the means to pay for job training to becoming a skilled professional working in a medical office. On September 11, the Newport resident was honored for her achievement by the organizations that helped her help herself. Mrs. Critzer, now 50, was one of about a half-dozen individuals and employers recognized during the JobLink Appreciation Luncheon and Awards Presentation held at the Morehead City-Beaufort Elks Lodge No. 1710.

The Carteret County Chamber of Commerce in partnership with the JobLink Career Center sponsored the event. The JobLink Career Center provides job seekers access to a variety of employment and training services hosted by the N.C. Employment Security Commission (ESC).

"Robin's life has been positively impacted by the efforts of the JobLink and the assistance she received from multiple JobLink partners, said Mary Brown, manager of the Morehead City ESC office, who announced the Award of Achievement. Mrs. Brown said Mrs. Critzer had searched diligently for four months to find a job, submitting resumes daily, but to no avail. A meeting with an Employment Consultant at the JobLink included a discussion about the possibility of Mrs. Critzer returning to school. "Robin didn't think she could afford to go back to school, so the employment consultant referred her to the WIA (Workforce Investment Act) adult coordinator, Carteret Community College's partner in the JobLink," Mrs. Brown said.

Mrs. Critzer was accepted into the WIA program and enrolled in the fall 2007 classes of the Medical Office Ad-

ministration program, a cooperative effort between CCC and Pitt Community College. "She was concerned about being an older student, but it wasn't long before she set the bar high — maintaining an "A" average in all of her classes for all two years. Robin graduated in July 2009 with an Associate Degree in medical office administration. She worked in an internship program at Carteret OB/GYN where upon completion she was hired and is currently working as a medical transcriptionist," said Mrs. Brown. "I'm really grateful to WIA, the program and my family for supporting me," Mrs. Critzer said.

The luncheon was the centerpiece of "JobLink Appreciation Week" in Carteret County. Chamber Chairman Bruce Caldwell said the purpose was to celebrate the opportunity that exists here for job seekers to improve their skills and for employers to build a stronger workforce — both by taking advantage of the JobLink partners' services.

During the event, a small company and the largest industrial employer were both honored as Employers of the Year. Fleet Readiness Center East at Marine Corps Air Station Cherry Point received the award in the large employer category, which was presented to commanding officer Col. Scott Loch. "Nobody employs more Carteret County residents - 1,174 people at last count — than Fleet Readiness Center East," said Mr. Caldwell, who presented the award.

FRC East has a total workforce of about 3,400 and has provided depot maintenance, engineering and logistics support on a variety of aircraft, engines and components for all branches of the U.S. military. Its customers include

more than 200 Navy and Marine activities, 24 foreign nations, five U.S. Air Force activities, three U.S. Army activities and two other federal agencies.

In the small employer category, Jim Chalk and Len Gibbs of Chalk & Gibbs Insurance and Real Estate of Morehead City accepted the Employer of the Year Award. Chamber President Mike Wagoner presented Community Advocate awards to the N.C. Aquarium at Pine Knoll Shores and WTKF — 107.1 FM, The Talk Station. The awards recognized employers — large and small — that "go the extra mile to make Carteret County a better place to live, work, and raise your families." Mr. Wagoner said. The skilled trades professional of the year was presented to Billy Loyd of W.F. Loyd Painting of Newport. Pride Electric owner Ray Flores, presented the award. The final award was presented by the former Morehead City ESC Office Manager Dan Williams on behalf of the JobLink Partners and Eastern Carolina Workforce Development Board to Mr. Wagoner by presenting him with an award of recognition in implementing the JobLink Appreciation Week in Carteret County, which began five years ago.

The keynote address was delivered by NC ESC Chairman Moses Carey, Jr. who said that the JobLink services have never been more valuable or needed than during the current economy. He discussed the agency's strategic planning efforts and how their focus is on continuing quality improvements in a way that strengthens the economy and how customers are served. This year's event was well attended by community leaders and employers.



Lenoir County JobLink Ready to Help Unemployed

The Lenoir Community College Workforce Development Department and the JobLink Career Centers in Lenoir, Greene, and Jones counties offer a wide range of services to meet the employment and training needs of individuals who have lost their jobs because of plant closings or layoffs. The Lenoir Community College JobLink Career Center is comprised of partner organizations including the Employment Security Commission, Greene Lamp Inc., Eastern Carolina Workforce Board, Lenoir County Department of Social Services, Vocational Rehabilitation, Telamon Corporation, Mid-East Title V Program, U.S. Army, Job Corps, St. Peter Church of Christ (Project Share), and the Lenoir Community College Basic Skills Program. This partnership makes Lenoir Community College a user-friendly One Stop Career Shop.

The JobLink consultants can assist those who are unemployed with setting short-term and long-term goals. Basic JobLink services are available to any local resident and specialized services are offered to individuals facing more serious employment obstacles such as plant closings and layoffs. Some people may only require assistance regarding job opportunities; others may require more intensive career assistance. In either case, Lenoir Community College is equipped to handle their needs.

Services offered through the JobLink Career Centers may include skills assessments, resume preparation, job search assistance, financial aid, community resources, career planning, and occupational skills training. Our Human Resource Development Department offers free classes to those who qualify. These classes include computer skills for the beginner, computer skills for the workplace, basic skills for office careers, and other classes vital to basic skills needed for employment such as the North Carolina Career Readiness Certification.

In some instances, individuals may qualify to receive Workforce Investment Act federally funded training vouchers that can be used to pay for career relevant education and training at Lenoir Community College. With today's challenging economy, characterized by an ever-increasing unemployment rate, it is vital to know Lenoir Community College's doors are open to everyone.

We pledge our support in assisting the citizens in Lenoir, Greene, and Jones counties in upgrading job skills and becoming re-employed.

Spirit Aerospace Construction on Schedule



On September 16, Spirit hosted a briefing and walking tour of the under-construction plant for local media. Rick Davis, Spirit Aerospace company's North Carolina site operations director, announced that the 500,000 square foot facility is scheduled to open for production in April 2010. The entire plant, including offices, should open that summer. With over 300 construction

workers on board, the massive construction project being funded in large part by a \$100 million Golden LEAF Foundation grant is on schedule and on budget according to Spirit officials. The facility, which is being built on 304 acres of land at the Global TransPark, will be used to fabricate portions of the fuselage and the wings for Airbus' new A350 Xtra Wide Body passenger aircraft.

The aircraft components will be built in sections in Kinston and placed on trains bound for the port at Morehead City, then delivered to France for final assembly and delivery to Airbus. "This project has gone extremely well," Davis said. "We are really pleased." He said the construction crews, working under

the direction of general contractor Haskell Construction Co. of Jacksonville, Fla., "have performed near flawlessly at the site."

Rob Wrigley, director of government relations for Airbus Americas Inc., based in Herndon, Va., said Spirit's Kinston site is Airbus' largest investment with a firm in the U.S., since Airbus will provide the tooling machinery used there.

"It is people that make this work," Davis said. "We have a great team; we have a great set of partners and we are really excited to be here."

Sanderson Farms Moves Forward With Construction Plans

Sanderson Farms' financial condition continued to improve during the third fiscal quarter of 2009, which ended July 31. This improvement led Sanderson officials in July to move forward with its \$121 million construction plans for a new Kinston processing site, which had been delayed for one year. For now, construction work continues on the new Sanderson feed mill and hatchery in Kinston. Mark Pope, director of economic development for Lenoir County, said work would start in about three weeks to build the poultry processing plant. "They are moving

fast," Pope said. "Sanderson Farms has a lot to accomplish before the projected 2011 start date."

Sanderson said the company expects a 7 percent poultry production increase in 2010 for its business. "We are focused on Kinston right now," Sanderson said. "We have a \$120 million commitment." Sanderson's net sales for the third quarter of fiscal 2009 were \$504 million, as compared to \$466 million during the same period in 2008. The company reported a net income of \$43 million in the third fiscal quarter this

year. "Our results for the third quarter of fiscal 2009 reflect much improved market conditions for our company and our industry when compared to last year," Sanderson Farms Chief Executive Officer Joe Sanderson Jr. said. "The combination of lower costs and improved market conditions resulted in much higher margins for the quarter."

The Kinston processing plant is set to begin production during the first fiscal quarter of 2011. About 1,500 employees are expected to work at the new processing plant.
