**SUBJECT:** Rescission of Eastern Carolina Local Area Issuances related to Workforce Investment Act (WIA)

**PURPOSE:** To rescind Eastern Carolina Local Area Issuances related to Workforce Investment Act (WIA)

**BACKGROUND:** On July 22, 2014, President Obama signed the Workforce Innovation and Opportunity Act (WIOA) (Pub. L. 113–128), comprehensive legislation that reforms and modernizes the public workforce system. It reaffirms the role of the public workforce system, and brings together and enhances several key employment, education, and training programs. WIOA provides resources, services, and leadership tools for the workforce system to help individuals find good jobs and stay employed and improves employer prospects for success in the global marketplace. It ensures that the workforce system operates as a comprehensive, integrated and streamlined system to provide pathways to prosperity for those it serves and continuously improves the quality and performance of its services.
